### FSSAI alerts fruit traders to ensure compliance with prohibition of Calcium Carbide in fruit ripening

New Delhi, May 19 (PIB)

The Food Safety and Standards Authority of India (FSSAI) has alerted traders'/fruits handlers/Food Business Operators (FBOs) operating ripening chambers to strictly ensure compliance with the prohibition on Calcium Carbide for artificial ripening of fruits, particularly during the mango season. FSSAI is also advising Food Safety Departments of States/UTs to remain vigilant and take serious action and deal stringently against person(s) indulging in such unlawful practices as per the provisions of FSS Act, 2006 and Rules/ Regulations made thereunder.

Calcium Carbide, commonly used for ripening fruits like mangoes, releases acetylene gas which contains harmful traces of arsenic and phosphorus. These substances, also known as 'Masala', can cause serious health issues such as dizziness, frequent thirst, irritation, weakness, difficulty in swallowing, vomiting and skin ulcers, etc. Additionally, acetylene gas is equally hazardous to those handling it. There are chances that Calcium Carbide may come in direct contact with fruits during application and leave residues of arsenic and phosphorus on fruits.

Due to these dangers, the use of Calcium Carbide for ripening fruits has been banned under Regulation 2.3.5 of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011.

This regulation explicitly states, "No person shall sell or offer or expose for sale or have in his premises for the purpose of sale under any description, fruits which have been artificially ripened by use of acetylene gas, commonly known as carbide gas."

Considering the issue of rampant use of banned Calcium Carbide, FSSAI has permitted the use of ethylene gas as a safer alternative for fruit ripening in India. Ethylene gas can be used at concentrations up to 100 ppm (100 ?l/L), depending upon the crop, variety and maturity. Ethylene, a naturally occurring hormone in fruits, regulates the ripening process by initiating and controlling a series of chemical and financial cyber fraud the citizens: biochemical activities. The treatment of unripe fruits with ethylene gas has been observed > If a WhatsApp triggers the natural ripening process until the fruit itself starts producing ethylene in substantial quantities.

Further, the Central Insecticides Board and Registration Committee sent from random number is received, (CIB & RC) has approved Ethephon 39% SL for the uniform ripening of mangoes and other fruits.

FSSAI has published a comprehensive guidance document titled "Artificial Ripening of Fruits - Ethylene gas a safe fruit ripener" (https:/ /www.fssai.gov.in/upload/uploadfiles/files/Guidance\_Note\_ Ver2\_Artificial\_Ripening\_Fruits\_03\_01\_2019\_Revised\_10\_02\_2020.pdf) suggesting the Food Business Operators to follow the procedure for Amazon, Flipkart, or authentic. artificial ripening of fruits. This document outlines a Standard Operating Procedure (SOP) incorporating all aspects of artificial ripening of fruits by ethylene gas viz. Restrictions, Requirements for Ethylene Ripening System/Chamber, handling conditions, Sources of Ethylene Gas, Protocol for application of Ethylene gas from various sources, post treatment operations, safety guidelines etc.

students does not have Aadhaar number, he/she can submit his/her EID number. However, the payment shall be released only after obtaining the Aadhaar Number and shall be disbursed to the Aadhaar seeded bank account of the student only.

Income Certificate: Income declaration of self employed parents/ guardian should be in the form of a certificate issued by a Revenue Officer not below the rank of Tehsildar. Employed parents/guardians are required to obtain Income Certificate from their employer and submit consolidated certificate from Revenue Officer including any other additional source of income.

> For the competitive exams for which the qualifying exam is class XII, benefits under the scheme will be available to a candidate only if the candidate has passed class XII or is studying in class XII as on the date of receiving the benefit under the scheme. Student will be required to declare the marks obtained by him/her in class X in the application form. Students having less than 50% marks in their class X exam, shall not be considered under the scheme.

Further, in case of competitive exams for which the qualifying exam is Under Graduate level only/students/candidates having completed the Under Graduate level course or studying in the final year of the Under Graduate course, student will be required to declare the marks obtained by him/her in class XII in the application form. Students having less than 50% marks in their class XII exam, shall not be considered under the scheme.

Benefit under the Scheme can be availed by a particular student not more than twice, irrespective of the number of chances he/she may be entitled to take in a particular competitive examination and irrespective of the number of stages in the exam. The students will be required to provide a declaration that he/she has not taken benefit more than twice under the Scheme or any other similar coaching scheme run by the Central or State Government.

The candidate shall be precluded from availing benefit under any other coaching scheme of the Centre or State Government and will be required to provide a declaration to this effect. A list of beneficiaries availing the scheme will also be uploaded on the website of the Ministry and shall be shared with Central Universities/Central Institutes to avoid possibility of the candidate availing benefits of similar coaching scheme simultaneously or more than twice.

The maximum number of awards would be 25. However, any relaxation to this maximum number may be permitted at the discretion of the National Selection Committee. The Award in each category shall carry a Medal, a Certificate and Cash Prize of Rs. 1,00,000/-.

These awards aim to give due recognition to young hearts who have done selfless acts of exceptional abilities and outstanding achievements. Child Bravery Award is given to a child to acknowledge her /his selfless service in the face of risk to her/his own life; and /or an act of outstanding courage and daring, against an act of mental strength, quick wit and presence of mind in the face of grave danger to self and society.

The Child Excellence Award is given to children with exceptional abilities and outstanding achievements in Sports, Social Service, Science & Technology, Environment, Arts & Culture and Innovation, which deserve due recognition at the national level. These awards are conferred by the Hon'ble President of India in a special ceremony at New Delhi.

Any child, who is an Indian citizen and residing in India, and not exceeding 18 years (as on the last date of receipt of application/ nomination) may apply for the award. The act/ incident/achievement should have been within 2 years of the last date of receipt of application/nomination for the year of consideration in the website i.e. https:// awards.gov.in. The applications for the PMRBP 2024 will be received only on the online portal https://awards.gov.in upto 31.07.2024, designed for this purpose.
